MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITY POLITEHNICA OF BUCHAREST

Represented by Mr. Mihnea Costoiu, Rector

AND

KING DANYLO UNIVERSITY

Represented by Mr. Myroslav Lutskyi, Rector

PREAMBLE

This **Memorandum of Understanding** is intended to promote international cooperation between the University POLITEHNICA of Bucharest and King Danylo University.

The University POLITEHNICA of Bucharest, represented by Mr. Mihnea Costoiu, Rector, and King Danylo University represented by Mr. Myroslav Lutskyi, recognizing the benefits to their respective universities from the establishment of institutional links, hereby agree to enter into this agreement for the following purpose.

Throughout this MOU, each party may be referred to as "Party" and together as "Parties". Throughout this MOU, the institution accepting visiting staff or students will be referred to as the "Host Institution". The institution of origin of visiting staff or students will be referred to as the "Home Institution".

1. PURPOSE OF AGREEMENT

The purpose of this agreement is to develop academic and educational cooperation between the two universities and to cooperate in their mutual interest for a range of higher educational activities.

2. AREAS OF COOPERATION

Possible areas of collaboration may include, but will not be limited to, the activities detailed below.

- (a) Conducting joint research and development project
- (b) Cooperation in individual projects
- (c) Organization of lectures, symposia, international meetings, conferences, and workshops
- (d) Exchange of academic staff, researchers, and students
- (e) Exchange of information, teaching materials, technological and scientific publications
- (f) Providing opportunities for professors and researchers to give lectures
- (g) Search for opportunities to collaborate in the future

3. IMPLEMENTATION

- 3.1. All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary budget for the program of activity as the need may arise.
- 3.2. Each of the Parties shall be fully responsible financially for the activities carried out under their direction or by their staff, except as otherwise agreed by the Parties.
- 3.3. The Parties will designate one Officer each, who will develop and coordinate specific programs or activities between them.
- 3.4. Neither Party shall levy tuition or other state fees on guest students. However, there may be other incidental fees required by the host institution.

4. INTELLECTUAL PROPERTY

Except in promoting the activities proposed in Article 2 among its faculty and students, neither Party may use the name of the other Party in any form without a prior express written permission of the other Party.

5. PRIVACY AND PERSONAL DATA

For the purpose of this Clause:

The term "GDPR" means Regulation (EU) 2016/679, the General Data Protection Regulation of the European Parliament and Council, and any legislation, rules, or regulations issued by applicable Supervisory Authorities.

During the term of this MOU and in connection with any Transfer or Processing of Personal Data in the context of any cooperation under this MOU, as the case may be, each Party hereby undertakes that it shall:

- a. Comply with all applicable laws and ensure an appropriate protection of Personal Data in accordance with applicable regulations and rules, including but not limited to, the GDPR or similar privacy or data protection laws applicable in the state, country or countries where Personal Data is collected or held or otherwise processed (collectively, the "Data Protection Laws").
- b. Implement commercially reasonable technical and organizational security procedures and measures to preserve the security and confidentiality of the Personal Data received under this MOU.
- c. Obtain all necessary consents from the respective Data Subject under the Data Protection Laws and will not Transfer Personal Data to third parties without prior notification to the respective Data Subject.

6. DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately after signature by the representatives of both University POLITEHNICA of Bucharest and King Danylo University representatives for a period of five (5) years and is subject to revision or modification by mutual agreement.

7. AMENDMENTS

7.1 This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both universities.

7.2 In the event of any unforeseen incident during collaborative activities in either country both universities agree to negotiate a mutually acceptable solution.

7.3 Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the universities shall endeavor to exercise best efforts to negotiate their differences.

8. TERMINATION OF AGREEMENT

This agreement may, at any time during its period of validity, be terminated by either party upon prior notice to the other in writing not later than six months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.

9. APPROVAL

In agreement with the above terms of participation, the authorized representatives of the University POLITEHNICA of Bucharest, and King Danylo University hereby affix signatures.
