



## COOPERATION AGREEMENT

**Higher Educational Institution "King Danylo University"**, hereinafter referred to as **KDU** and **Technikum Academy z.s.** and **Centre of Educational Innovations** confirming their interest in the development of cooperation in the field of research and teaching to their mutual advantage, have agreed as follows.

### Art. 1

The scope of this Agreement comprises education, research and student exchange.

### Art. 2

Both Parties agree on the following forms of cooperation:

#### **in the field of education:**

- to exchange experiences on teaching methods and materials,
- to exchange staff members for the purpose of lectures, seminars, conferences etc.

#### **in the field of research:**

- to carry out joint research projects,
- to exchange scientific and technical information,
- to coordinate research studies,
- to exchange scientific results in defined subjects areas,
- to publish the results in these areas,
- to apply jointly for international and/or national calls for projects,
- to organize joint seminars, conferences, symposia etc.

#### **in the field of student and staff exchange:**

- to carry out joint research programmes by students,
- to exchange students under student traineeship schemes,



**Art. 3**

In order to achieve specific objectives and tasks under this Agreement, the Parties shall sign a separate detailed document which shall provide for the rules of cooperation in particular such as method of financing, time and period of the Parties' representatives' visits and intellectual property rights.

**Art. 4**

3. The Parties of this Agreement agree to take necessary steps and ensure mutual support for the purpose of raising funds for the realisation of the provisions of this Agreement.
4. This Agreement does not entail any financial consequences to both Parties.

**Art. 5**

5. This Agreement enters into force when signed and is concluded for 5 years.
6. If the parties, at least 3 months before expiration of this period, do not initiate to extend it, the Agreement terminates.
7. This Agreement may be terminated after a prior written notice of termination submitted by the 30<sup>th</sup> of June of the given year with effect at the end of that calendar year.
8. All changes and amendments to this Agreement shall be null and void unless made in writing.

3. This Agreement is made in English in three counterparts.
4. Each Party will receive one copy.
