REQUIREMENTS FOR ABSTRACT FORMATTING

1. The materials must be written in Ukrainian or English (the working languages of the conference).
2. The abstracts should be typed in Microsoft Word 2003, XP on an A4 (210×297 mm) sheet, with the following margins (mm): top – 20, bottom – 20, left – 20, right – 20.
3. UDC (Universal Decimal Classification) should be in Times New Roman, size 14, bold, left-aligned, without paragraph indentation.
4. In the top right corner (without abbreviations) – the author's full name, course, specialty, and the full name of the institution where the author is studying; the full name of the scientific supervisor, their position, academic degree, title, and the institution where the supervision is conducted, city, country, ORCID (line spacing – 1, italicized; author's and supervisor's names – bold).
5. On the next line, the title of the abstract should be in capital letters (Times New Roman, bold, size 14).
6. After one blank line, the main text of the abstract should be in Times New Roman, size 14, regular, line spacing – 1.5, indentation – 1.25 cm.
7. Tables should be concise, clear, and contain only essential data. Table titles should be in Times New Roman, size 14, bold, center-aligned, without indentation. The table text should be in Times New Roman, size 12, regular, line spacing – 1, left-aligned, without indentation. Example:

8. Figure captions should be in Times New Roman, size 12, bold, center-aligned, without indentation. Example:

Fig. 1 Dynamics of Foreign Direct Investment in Ukraine in 2020–2023

9. References should be listed at the end under the title "References" (bold), following the Ukrainian National Standard DSTU 8302:2015 (adopted in 2015).

In-text citations should be indicated in square brackets with the source number in the reference list, followed by the page number(s), e.g., [7, p. 16], [2, pp. 4–8].

10. Non-breaking spaces should be used by pressing Ctrl + Shift + Space in case of unit abbreviations, page numbers, and place names. Clearly distinguish between a hyphen (-) and a dash (–).

11. Abstract length: up to 4 pages (excluding the reference list).

12. Materials that do not meet the requirements or are submitted after the deadline will not be considered.
