

COOPERATION AGREEMENT



between

KING DANYLO UNIVERISTY, Ukraine
represented by
Rector, Prof., Dr. Myroslav Lutskyi

and
ZÁHONY TOWN COUNCIL, Hungary
Mayor, Helmeczi László

Higher Educational Institution “King Danylo University”, hereinafter referred to as **KDU** and **Záhony Town Council**, confirming their interest in the development of cooperation in the field of research and teaching to their mutual advantage, have agreed as follows.

Art. 1

The subject of this Agreement is a partnership in the following areas:

- Exchange of experience in education and science through the implementation of exchange projects among youth and lecturers, internships, training programs, and studies, as well as the development of joint educational programs.
- Exchange of administrative staff to enhance qualifications.
- Joint organization of international research, conferences, development of coordinated programs, and publication of articles and essays.
- Preparation and implementation of other joint projects in education, science, tourism, culture, arts etc.

Art. 2

To achieve specific objectives and tasks under this Agreement, the Parties shall sign a separate detailed document that shall provide the rules of cooperation, in particular, such as the method of financing, the time and period of the Parties' representatives' visits, and intellectual property rights.

Art. 3

1. The Parties of this Agreement agree to take necessary steps and ensure mutual support to raise funds for the realization of the provisions of this Agreement.
2. This Agreement does not entail any financial consequences to both Parties.

Art. 4

1. This Agreement enters into force when signed and is concluded for 5 years.
2. If the parties, at least 3 months before the expiration of this period, do not initiate to extend it, the Agreement terminates.

3. This Agreement may be terminated after a prior written notice of termination is submitted by the 30th of June of the given year, with effect at the end of that calendar year.
4. All changes and amendments to this Agreement shall be null and void unless made in writing.

Art. 5

1. This Agreement is made in English in two counterparts.
2. Each Party will receive one copy.
