REQUIREMENTS FOR ABSTRACT FORMATTING

1. The materials should be prepared in Ukrainian or English.

2. The abstract should be typed in Microsoft Word 2003, XP on 210x297 mm paper, with the following margins (in mm): top - 20, bottom - 20, left - 20, right - 20.

3. Authors must specify the Universal Decimal Classification (UDC) under which the scientific work has been prepared. It is recommended to use the UDC classifier. The UDC should be presented as follows: Times New Roman font, size 14, bold, no paragraph indentation, alignment – left.

4. In the upper right corner (without abbreviations): author's name and surname, their position, academic degree, academic title, the full name of the institution they are affiliated with, city, country, and ORCID (line spacing – 1, italic; author's name and surname – bold font).

5. On the next line, specify the title of the abstract in uppercase letters (Times New Roman font, bold, size 14).

6. After one line, begin the main text of the abstract (Times New Roman font, size 14, regular, line spacing – 1.5, paragraph indent – 1.25).

7. Tables should be concise, clear, and contain only the essential information necessary to illustrate the essence of the article.

8. The table title should be formatted as: Times New Roman, size 14, no paragraph indentation, bold, aligned center.

9. Text in the table: Times New Roman, size 12, regular, line spacing – 1, no paragraph indentation, aligned left. Example:

8. Figure captions: Times New Roman, font size 12, bold, no paragraph indentation, centered alignment. Example:

Fig. 1 Dynamics of Direct Foreign Investment Changes in Ukraine in 2020–2023.

9. Figures or illustrations should be placed within the main text of the article (with text wrapping both above and below). Figures or illustrations are numbered sequentially with Arabic numerals. References to them in the text are given in parentheses. For example: ("Fig. 1." or "Ill.1"). Figures or illustrations must be of high quality, suitable for reproduction and printing.

10. List of references – at the end of the text under the title "List of References" (font – bold), following the National Standard of Ukraine DSTU 8302:2015, developed in 2015.

11. In-text citations should be marked with square brackets, indicating the reference number in the list, followed by the page number(s) (e.g., [7, p. 16], [2, pp. 4–8]).

12. A non-breaking space should be used by pressing Ctrl + Shift + Enter in cases that require word abbreviations (e.g., units of measure, page numbers, settlements, etc.). Clearly differentiate between a hyphen (-) and an en dash (–).

13. Text length: up to 4 pages, excluding the list of references.

14. Materials that do not meet the requirements or are submitted after the established deadline will not be considered.

15. The use of sources published in Russian in any country, as well as sources in other languages published in Russia and Belarus (with justified exceptions), is not recommended.
